THIS WRIT PETITION (CIVIL) HAVING COME UP FOR ADMISSION ON 26.09.2022, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

Even though there are various assertions, allegations and averments made and urged in this writ petition, when this matter was called today, the learned counsel for the petitioner confined his plea that the first respondent be directed to take up Ext.P5 representation, pending before the Government, and to issue appropriate orders thereon, within a time frame to be fixed by this Court.

- 2. Smt.Nisha Bose learned Senior Government Pleader, responded to the afore submissions of Sri.Sajan Vargheese learned counsel for the petitioner, saying that if the petitioner only requires Ext.P5 to be taken up and disposed of by the first respondent, there does not appear to be any legal impediment in doing so; but prayed that this Court may not make any affirmative declarations as to the entitlement of the petitioner to any relief and leave it to the competent Authority to take a decision on it in terms of law.
- 3. In the afore circumstances, I order this writ petition and direct the first respondent to take up and dispose of Ext.P5, after affording an opportunity of being heard to the

petitioner, as also to the Manager of the school; thus culminating in an appropriate order thereon, as expeditiously as is possible, but not later than three months from the date of receipt of a copy of this judgment.

Needless to say, if the petitioner has any approved service, including in the post of UPSA, the competent Authority will be obliged to disburse the salary to her in such post, subject to the higher one being given to her, resultant to the decision to be taken in terms of the afore directions.
