JUDGMENT

The above writ petition is filed with the following prayers:

- i) Declare that the petitioner can make appointment of Principals by promotion under Section 59(2) of the Mahatma Gandhi University Act, 1985 in St. Thomas College, Kozhencheri irrespective of the provisions of the UGC Regulations (on Minimum Qualifications for appointment of Teachers and Other Academic Staff in Universities and Colleges and Other Measures for the Maintenance of Standards in Higher Education) 2010 and that the 2nd respondent University is bound to approve the same subject to the qualifications prescribed in the Kerala University Regulations Relating to Qualifications of Teachers;
- ii) Declare that the provisions of the UGC Regulations (on Minimum Qualifications for appointment of Teachers and Other Academic Staff in Universities and Colleges and Other Measures for the Maintenance of Standards in Higher Education) 2010 has no application to the appointments of Principals made by the petitioner by way of promotion;
- iii) Call for the records leading to Exhibit P11; issue a writ of certiorari or any other appropriate writ or order, quash and set aside Ext.P11 to the extent it makes the UGC Regulations (on Minimum

Qualifications for appointment of Teachers and Other Academic Staff in Universities and Colleges and Other Measures for the Maintenance of Standards in Higher Education) 2010 applicable for the appointments of Principal in the petitioner's college;

- iv) Declare that Exhibit P11 order is ultra vires the powers of the Syndicate of the 2nd respondent Mahatma Gandhi University and hence null and void;
- v) Call for the records leading to Exhibit P13, Exhibit P14 & Exhibit P15; issue a writ of certiorari or any other appropriate writ, or order or direction, quash and set aside Ext.P13,Ext.P14 & Ext. P15 to the extent it affects the selection and appointment of Teachers including Principal in the petitioner's college through Direct Recruitment;
- vi) Declare that the provisions of the UGC Regulations (on Minimum Qualifications for appointment of Teachers and Other Academic Staff in Universities and Colleges and Other Measures for the Maintenance of Standards in Higher Education) 2010 has no application to the petitioner's college for the selection and appointment of Teachers including Principals through Direct Recruitment as stated in the Mahatma Gandhi University Act, 1985;
- vii) issue such other orders as this hon'ble Court may deem fit and proper according to the facts and circumstances of the case; [sic]
- 3. The counsel appearing for the UGC submitted that the point raised in this writ petition is covered against the petitioner as per judgments in *Aleyamma Kuruvila and anr. V. Mahatma*

Gandhi University, Kottayam [2022 (7) KHC 46] & Aleyamma Kuruvila V. Mahatma Gandhi University, Kottayam [2023 (2) KHC 11], If that is the case, no orders can be passed in this case.
