JUDGMENT

The petitioner claims the benefit of interest subsidy on educational loan. The matter is engaging the attention of the third respondent in Ext.P5 application. The same has to be forwarded to the first respondent to be dealt with in accordance with Ext.P4 Government Order.

- 2. The third respondent bank points out that interest subsidy can at best extend to ₹ 1.64 lakes only. The total liability is ₹ 7.24 lakes as on today and the balance amount comes to about ₹ 5,60,000/- (Rupees five lakes sixty thousand only)
- 3. I permit the petitioner to pay the sum of ₹ 5,60,000/(Rupees five lakhs sixty thousand only) with interest in eight equal monthly instalments. The monthly instalments shall start from 1-10-2013.
- 4. The coercive steps pursuant to Exts.P6 and P7 notices shall be put on hold if the petitioner complies with the conditions in time. The coercive steps can surge ahead if the petitioner commits default in the payment of anyone of the instalments.

5. The right to recover the disputed sum of ₹ 1.64 lakhs would depend upon the eligibility for interest subsidy. The bank is permitted to take steps in this regard only after the final orders are passed by the first respondent. The first respondent shall pass orders within two months after receipt of Ext.P5 application from the third respondent bank.

The writ petition is disposed of.
