### **JUDGMENT**

# Dated this the 7<sup>th</sup> day of December 2021

This Writ Petition is filed seeking the following reliefs:-

- (i)Issue a writ of certiorari or any other appropriate writ order or direction, quashing Ext.P4 order issued by the 4<sup>th</sup> respondent and also the proceedings issued vide Ext.P6 notice dated 16.02.2021 for cancellation of the building permit.
- (ii)Issue a writ of mandamus or any other appropriate writ order or direction directing the respondents 32 to 4 to change the building permit issued vide Ext.P2 in the name of the 1<sup>st</sup> petitioner and also to allot building number and occupancy certificate to the 1<sup>st</sup> petitioner pending orders issued by the 1<sup>st</sup> respondent in Ext.P8 application.
- 2. Heard the learned counsel for the petitioner, the learned Government Pleader as well as the learned standing counsel appearing for respondents 2 to 4.
- 3. It is submitted by the learned counsel for the petitioner that the petitioner is the owner in possession of 2.326 Ares of land in Survey No.262/3B (262/35) if Feroke Amsom, Nalloor Desom of Kozhikode Taluk, in which a commercial building has been constructed on the strength

of Exhibit P2 building permit issued on 13.03.2019. submitted that when the petitioner approached the respondents for an occupancy certificate and numbering of the building, it was stated that the building is constructed in property which is shown as nilam in the basic tax The petitioner, therefore, submitted Exhibit P8 application, in Form No.6, for permission for use of the property for other purposes. It is submitted that the said application is not being considered and in the meanwhile the building of the petitioner is also not being permitted to put to use. Learned counsel for the petitioner submits that the construction was carried out on the basis of a valid building permit and that the respondents cannot, now, refuse to number the building.

Having heard the contentions advanced on either side, there will be a direction to the 1<sup>st</sup> respondent to take up Exhibit P8 application submitted by the petitioner and to consider and pass orders on the same after considering all relevant aspects of the matter and obtaining all reports from the Village Officer, taking note of Exhibit P7

Government Order as well. It is made clear that I have expressed no view on the merits of the matter and that the application is liable to be considered in accordance with law by the 1<sup>st</sup> respondent after considering all other relevant aspects. Appropriate orders shall be passed within a period of three months from the date of receipt of a copy of this judgment. The petitioner shall produce a copy of the writ petition along with a copy of the judgment before the 1<sup>st</sup> respondent for compliance.

In the meanwhile, the 2<sup>nd</sup> respondent shall number the building of the petitioner provisionally and permit occupancy of the same, subject to the orders to be passed by the RDO on Exhibit P8, within a period of two weeks. The petitioner shall produce a copy of the writ petition along with a copy of the judgment before the 1<sup>st</sup> respondent for compliance.

This writ petition is ordered accordingly.
