## **JUDGMENT**

The petitioner, who was working as a casual sweeper in the Village Office, Manarcadu, has filed this writ petition aggrieved by the termination of her services on the ground of a vigilance report that she was collecting bribe. Relying on the evidence adduced by the Vigilance Officials, the petitioner points out that termination is illegal and that she has not committed any such offences and she was only a Part-time Sweeper whose duty was confined to certain hours in the forenoon. It is also her case that the vigilance team had taken a decision without any material and only based on hearsay evidence. The petitioner points out that she had been working since the year 2000 onwards and on account of the illegal and unjust termination, she is deprived of her livelihood. From the proceedings it is clear that termination has been effected only on the basis of the direction from the Vigilance Department.

2. Pointing out these circumstances, the petitioner has approached the District Collector with Ext.P10 representation

before the 3<sup>rd</sup> respondent. As the petitioner has approached the 3<sup>rd</sup> respondent with Ext.P10 representation pointing out the grievances, I am of the view that it is only appropriate that the Government considers her representation Ext.P10 after affording an opportunity of hearing to the petitioner and passes orders considering the fact that she was working for more than 14 years as a Casual Sweeper.

In the above circumstances, the writ petition is disposed of directing the 3<sup>rd</sup> respondent to consider and pass orders on Ext.P10 representation after affording an opportunity of hearing to the petitioner within a period of two months from the date of receipt of a copy of this judgment. The 3<sup>rd</sup> respondent shall also consider the orders issued by the Government for regularisation of the Casual Sweepers while passing final orders.
