JUDGMENT

This writ petition is filed by the petitioner seeking the following relief:-

- (I) Issue a writ in the nature of mandamus or any other appropriate writ, order or direction to the 1st respondent to restore the pathway as shown in Ext.P1 completion plan with 3.6 metre all along the Chittilangatt Lane.
- 2. From the pleading put forth by the petitioner it is evident that 2nd respondent, flat owner encroached upon the pathway leading to petitioner's property which is a public pathway. According to the 1st respondent Corporation the sole relief sought for is implementaion of Ext.P5 order rendered by the Tribunal in appeal No. 420/2011 dated 29.08.2011 Taking into account the pleadings and the documents produced by the petitioner and hearing the respective counsel, I am of the considered opinion that writ petition can be

disposed of with appropriate directions. First respondent has filed a detailed counter affidavit. However fact remains what is sought for by the petitioner is implementation of Ext.P5 judgment.

In that view of the matter, this writ petition is disposed of, directing the petitioner 1st respondent to implement the directives contained in Ext.P5 order, if it has become final and conclusive, at the earliest, and at any rate, within two months from the date of receipt of a copy of this judgmnet, if required after securing participation of the respective parties.
