JUDGMENT

P.N. Ravindran, J.

The petitioners who have appeared for and passed the entrance examination conducted by the Commissioner for Entrance Examinations, Kerala for admission to professional degree courses 2015, have filed this writ petition mainly seeking a direction to respondents 4 to 13 to enter into seat sharing agreements with the State Government. They have also prayed for various other reliefs.

2. When the writ petition came up for hearing today, learned counsel appearing for the petitioners submitted that the petitioners have got admission for the MBBS degree course in Medical colleges outside the State of Kerala and that they have no subsisting grievance.

In such circumstances, the writ petition is closed as infructuous leaving open the contentions raised by the petitioners.
