**JUDGMENT**

The prayer in the writ petition is for a direction to the 2<sup>nd</sup> respondent to consider and dispose of Ext.P11 application and to quash Exts.P8 & P9. Exts.P8 & P9 are orders whereby the payment of basic tax has been restricted. The petitioner has preferred Ext.P11 before the 2<sup>nd</sup> respondent being aggrieved by Exts.P8 & P9.

2. The Government Pleader on instructions submits that Ext.P11 is received and is pending.

In the above circumstances, there will be a direction to the 2<sup>nd</sup> respondent to consider and pass orders on Ext.P11, after hearing the petitioner, at the earliest, at any rate, within three months from the date of receipt of a certified copy of this judgment. The petitioner may prefer any additional statement before the 2<sup>nd</sup> respondent within two weeks from today in support of Ext.P11. Exts.P8 & P9 shall be kept in abeyance to facilitate the 2<sup>nd</sup> respondent to consider and pass orders on Ext.P11.
