**JUDGMENT**

**Shaffique, J.**

The petitioner has approached this Court alleging harassment by police. It is stated that the petitioner has been vending Tobacco products and that it was not within the prohibited distance as per the guidelines issued by the Government. However, police is unnecessarily harassing her and is not permitting her to sell Tobacco products in her shop. It is stated that there is no educational institution within the 100 yards as claimed by police.

2. Sri.P. Vijayaraghavan, Learned State Attorney appearing for the respondents on instructions would submit that the petitioner's bunk shop is situated within 100 yards of two educational institutions and no Tobacco products can be sold in the said area.

Having regard to the aforesaid factual situation a direction as sought for cannot be granted in this writ petition and accordingly, the Writ Petition is closed.
