# **JUDGMENT**

When this matter was called today, Sri.C.A.Jojo – learned counsel for the petitioner, submitted that his client is giving up all reliefs, except with respect to the Equivalency Certificate on the basis of an out-of-court agreement between him and the Society. He added that the challenge against the promotion of the party respondent is also given up.

2. I notice from the files that, even though summons from this Court have been validly served on the respondents 1 and 2, they have chosen not to be present in person or to be represented through counsel; inferentially guiding me to the impression that the afore submissions of Sri.C.A.Jojo are without error.

In the afore circumstances, I allow this Writ Petition and set aside Ext.P3; and consequently direct the 1<sup>st</sup> respondent to grant all eligible benefits to the petitioner, without insisting on Equivalency Certificate with respect to his qualifications, subject to all other imperative and statutory requirements
