# **JUDGMENT**

The petitioner submitted that he had submitted a bid for the civil and maintenance works including replacing and installation of three air conditioners and other allied works in the Opthalmology Theatre of the Taluk Headquarters Hospital, Nedumkandom. He was the successful bidder completed the work. The Assistant Engineer attached to the 2<sup>nd</sup> respondent - Block Panchayat inspected the work after completion and issued a certificate on 24.08.2017, certifying that the cost of the work done by the petitioner at Rs.5,84,770/-. The copy of the valuation certificate is produced as Ext.P1 and the detailed estimate of the work prepared by the Assistant Engineer attached the the office of the 2<sup>nd</sup> respondent is marked as Ext.P2. Since the amount of Rs.5,84,770/- stated above has not been paid, he filed this writ petition.

2. A counter has been filed on behalf of the  $1^{\rm st}$  respondent stating that according to the store purchase rules,

for awarding civil works above Rs.1 lakh upto Rs.5 lakhs, tender should be called for and for works above Rs.5 lakhs E-tender should be made, and in the instant case no tender was called. Administrative sanction for the said work was not given by the Hospital Management Committee at that time. It is stated that technical sanction was also not given by the then Assistant Engineer of the Block Panchayat.

- 3. Heard the learned counsel for the petitioner and the learned Government Pleader.
- 4. The reason stated in the counter affidavit cannot be accepted for more than one reason. It is not in dispute that the petitioner completed an emergent work. There is no contention in the counter filed on behalf of the 1<sup>st</sup> respondent that the work was not completed satisfactorily. In view of the above, the reasons stated in the counter affidavit cannot be accepted at all.
  - 5. In the said circumstances, the respondents or the

competent authority are directed to pay Rs.5,84,770/- to the petitioner as cost for the work done as per Exts.P1 and P2

within six weeks from today. If the amount is not paid within six

weeks from today, interest at the rate of 12% shall also be paid

on the above-stated amount until the actual payment is made.

6. The respondents will be free to take appropriate action against officials who allegedly erred in awarding the

tender.

This writ petition is allowed as above.
