- "a) quash Ext.P5 dated 13.11.2014 issued by the 1st respondent directing the petitioner to provide 100% Bank Guarantee to cover the Duty Saved Amount.
- b) direct the respondents to limit the Bank Guarantee to 15% of the Duty Saved Amount to be furnished in favour of the concerned Customs Authorities provided for the manufacturer exporters coming under Customs Circular No:58/2004 as amended by Ext.P3 Customs Circular No:17/2009
- grant such other and further reliefs as are deemed just and proper in the circumstances of the case and
- d) award the costs of the petition."

The period of scheme was six years. The interim order granted by this Court, after the expiry of the scheme, would not be of no avail. The cause of action no longer subsists. Writ petition is closed.
