The petitioner is the wife of the detenu. The petitioner challenges the detention order passed under the Kerala Antisocial Activities (Prevention) Act, 2007. The detenu is involved in the following six crimes:

2. The last prejudicial activity was on 03.06.2023. The sponsoring authority submitted its report on 31.07.2023. The detention order was passed only on 18.10.2023. We note that there is a considerable delay in passing the detention order. If the sponsoring authority submitted its report within the reasonable time, the detaining authority ought to have passed the detention order immediately thereon. The live-link between the last prejudicial activity and the date of detention order must survive and otherwise, if it is snapped between those period, the detention order will cease to have any operative objection in the sense that the very idea of detention order is to prevent the recurrence of commission of offences. The detention order cannot be used to penalise a person. The

intention behind the Act is to prevent a person from repeating the offences.

3. In the light of the fact that more than three months have elapsed after sponsoring authority submitted its reports, we find no justification in passing such detention order. We hold that the live-link between the last prejudicial activity and the detention order have been snapped. Accordingly, the impugned order is set aside. The detenu is ordered to be released forthwith, provided, it he is otherwise not required in any other case under law.

This W.P. Crl. is disposed of as above.
