JUDGMENT

The captioned writ petitions are in respect of tenders invited by the Kerala Water Authority. The challenge in the writ petitions are fundamentally with respect to the additional performance guarantee directed to be furnished, out of which 50% by way of treasury fixed deposit and the balance by bank guarantee or other securities. The contention advanced by the petitioners are on the basis of the various notifications issued by the State Government granting benefit during the pandemic Covid-19 period, and also in the matter of submitting tenders below the probable amount of contract. However, by virtue of the notification issued in the year 2015, modified in the year 2019, if a bidder submits a bid 10% below the probable amount of contract, if it is invited items wise rates contract, additional performance guarantee is insisted upon. The case projected by the petitioners is that all the contracts in question are lumpsum contracts, which is clearly specified in the tender notifications and therefore, the insistence made by the

Kerala Water Authority that additional performance guarantee is to be furnished, if the bid submitted by the contractors are below 10% for each item of the contract, is bad in law and illegal. However, the contention put forth by the Kerala Water Authority is that as per the orders issued by the State Government if the contract value is exceeding five lakhs, all the tenders shall be invited through e-tender portal on item rate contract only. Therefore, according to the Kerala Water Authority all the tenders are invited by providing a schedule with respect to the items involved in the contract and therefore, the bidders participating in the contract have to quote the amounts for each item as provided in the schedule. The issue with respect to the benefits granted by the State Government exempting furnishing of additional performance guarantee and relaxation to the performance guarantee; the issue with respect to the tender submitted by the bidders in lump sum contracts and item wise rates contract were considered by this court in a batch of writ petitions and has rendered a

judgment dated 21.03.2023 in W.P.(C.) No. 14051/2022 and other connected cases. It was held therein specifically that in so far as the exemption granted by the Government from furnishing additional performance guarantee as per Government order dated 07.01.2021 for a period of one year was not extended; in the Government Order, dated 15.03.2022, the exemption is confining to the relaxation of the performance guarantee alone. In so far as the items wise rates contract is concerned, it was held that if the tenders are invited on the basis of percentage rates contracts, then the contractors are liable to furnish additional performance guarantee on the basis of '(X-10)%' of the estimated PAC; however, if the tenders are invited on the basis of items rates contract, then the contractors are liable to furnish additional performance guarantee for each item of work on the basis of '(X-10)%' of the estimated amount for each item of work. In fact, it was also held that merely because in the schedule attached to the detailed tender notice, the rates of each item is not provided by the

Kerala Water Authority, the contractors are liable to submit the tender by quoting rates against each item of the work shown in the schedule. However, in these petitions, learned Standing Counsel for the Water Authority has invited my attention to the Government Order dated 04.05.2019 bearing G.O.(P) No. 54/2019/Fin., dealing with execution of public works on item rate contracts to regulate abnormally high quoted and low quoted items. Therefore, learned Standing Counsel for the Kerala Water Authority submitted that as per the said Government Order, if the public work costing more than Rs.5 Lakhs is involved all tenders shall be invited through e-portal on item rate contract only. However, on the other hand, learned counsel for the petitioners submitted that going by the Government Order dated 04.05.2019, it is evident that unless and until the relevant clauses of Standard Bidding Document (SBD) and the Kerala Public Works Department Manual, 2012 is modified incorporating the said Government Order, Kerala Water Authority is not entitled to insist for submission of bid

showing the price for items wise rate. It is further contented by learned counsel for the petitioners that the Kerala Water Authority has to accept the Government Orders in its Board Meeting and there is no evidence produced by the Kerala Water Authority to show that the Government Order, dated 04.05.2019 is accepted by the Kerala Water Authority for inviting its tenders. In fact, all other Government notifications were taken note of in the earlier batch of writ petitions referred to above.

2. Learned Standing Counsel for the Water Authority in the context of submission made by learned counsel for the petitioners that the Water Authority has not accepted the Government Order dated 04.05.2019, has invited my attention to the provisions of the Kerala Water Authority (Authentication of Orders, Assurance of Property and Execution of Contracts) Regulations, 1992 (for short, 'the Regulation, 1992') made as per the powers conferred by Sub-section (1) and Clause (d) of Sub-Section (2) of Section 65 of the Kerala Water (Supply and Sewerage) Act,

1986. Regulation 5 of the Regulations, 1992 deals with execution of contracts for works and purchase of materials, stationary articles, furniture etc.; Sub-regulation (3) of Regulation 5 of the Regulations, 1992 makes it clear that; all agreements shall be executed for and on behalf of the Authority and the forms prescribed under the Stores Purchase Manual, the P.W.D. Code or the K.F.C. (Kerala Financial Code) as the case may be, shall *mutatis mutandis* apply, to the execution of contracts under the Regulation. Therefore, according to the learned Standing Counsel by virtue of the above statutory fiction the orders passed by the Government, in the matter of execution of public work would apply to the Kerala Water Authority.

3. I have heard learned counsel for the petitioners, Sri. George Mathew, Sri.V.Premchand, Sri.P.Shanes Methar, Sri.T.V. George and other counsel appearing for the petitioners and learned Standing Counsel for the Kerala Water Authority, Sri. V.V. Joshi, Sri. P.M. Johny and Sri. Georgie Johny and perused the pleadings and material on

record.

4. Even though the relevant Government Orders in respect of the matters were discussed in the earlier round of writ petitions, the Government Order, dated 04.05.2019 was not brought to my notice. Therefore, the only question to be considered is whether in the percentage wise rates contracts invited by the Kerala Water Authority exceeding Rs. 5 Lakhs whether the tenders are to be submitted through e-tender portal on items rates contracts. The Government Order, dated 04.05.2019 was brought into force in order to avoid time and cost overrun on account of deviations necessitated during the course of execution of work as per the Government Order, dated 15.01.2018, bearing G.O.(P).No.8/2018/Fin.; and instructions were issued to all Government Departments and PSUs to ensure the detailed investigation, design, estimation etc., while granting sanction itself. It was also found that some discrepancies have been observed while processing of tenders and execution of works under item rate contracts;

also instances have been noticed where the low quoted items were excluded during execution and excess quantities of high quoted items are executed without adequate technical justification resulting in heavy loss to the public exchequer. Therefore, in order to avoid such instances in future, the Government issued clarifications on item rate contracts to all Government Departments and PSUs. The relevant portion of the said Government Order dated 04.05.2019 reads as follows:-

- "1) Tenders for all public works costing more than Rs. 5 lakh shall be invited through E-tenders en Item Rate Contract only.*
- 2) The bidder who has quoted lowest total amount shall be considered as L1.*
- 3) The quoted rates of L1 for all items may be compared with current DSR and Current LMR. The items whose quoted rates are more than current DSR may be treated as High Quoted Items and less than current DSR may be treated Low Quoted Items.*
- 4) Negotiations shall be done with L1 only to reduce the high quoted rates so to explore the possibility for bringing them within DSR + 10% tolerance limit or LMR, which ever is lower.*

- 5) *The admissible contract amount will be least of (i) Negotiated Contract PAC L1 (ii) Estimate amount based on current LMR and (iii) Estimate amount based on current DSR plus 10% tolerance limit.*
- 6) *The quoted rates with deviation of more than (+/-) 25% over Technical Sanction Estimate Rates may be treated as Abnormally High Quoted Rates (AHQR) item/ Abnormally Low Quoted Rates (ALQR) item, as the case may be. In respect of AHQR item, under normal circumstances, the contract rate is applicable for the scheduled quantities in the Agreement only.*
- 7) *In case of quantities exceeding the agreement schedule quantities and up to 25% limit that are necessitated for proper completion of work, the contract rates of corresponding item shall apply.*
- 8) *For excess quantities, i.e., quantities in excess of 25% over agreement schedule quantities, the admissible rates shall be limited to Technical Sanctioned Estimate Rate modified by overall tender excess / tender deficit, as the case may be, subject to a maximum of PWD local market rates prevailing at the time of ordering.*
- 9) *In case of ALQR items, sanction of Technical Sanction authority shall be insisted before limiting execution of concerned item less than 75% scheduled quantity.*
- 10) *The relevant clauses of Standard Bidding Document (SBD) and Kerala PWD Manual 2012*

shall be modified accordingly."

On an analysis of the said Government Order, it is quite clear and evident that in the matter of tenders exceeding Rs.5 Lakhs, online bid is to be submitted on items rates contract only. In fact, in the earlier batch of writ petitions directions were issued taking into consideration, the Government Order dated 07.12.2019 and held that for percentage rate contracts, if the quoted amount of lowest bidder is 'X%' below estimated PAC, the Additional Performance Guarantee amount shall be '(X-10)%' of the estimated PAC and for items rates contracts, if the rate quoted by the bidder for an item of work is 'X%' below estimate cost where 'X' lies above 10%, the Additional Performance Guarantee for that item of work is equal to '(X-10)%' of the estimate amount for that item of work; and the total of Additional Performance Guarantee for the whole work is the total of individual Additional Performance Guarantee for each item of work calculated as above. But now going by the Government Order dated 04.05.2019, the

modality for the tenders exceeding Rs. 5 Lakhs is prescribed. As I have pointed out above, by virtue of the provisions of the Regulations, 1992, the Kerala Water Authority has to adhere to the orders issued by the State Government in the matter of execution of public works. Therefore, the contention advanced by the petitioners that the Managing Board of the Kerala Water Authority has not adopted the Government Order, dated 04.05.2019 cannot be sustained under law.

5. In fact, when many of the writ petitions were admitted to the files of this court, interim orders were passed directing the Kerala Water Authority to execute the agreement with the petitioners on condition that petitioners execute a simple bond undertaking to furnish additional performance guarantee, if and when directed so by this Court and also satisfying with other requirements of the notice inviting tender. Taking into consideration, the peculiar facts and circumstances consequent to the interim orders passed by this Court, the following directions were

issued:-

- “1. If the work in accordance with the agreement is completed by the contractors, no Additional Performance Guarantee shall be insisted upon.
2. If the work has progressed to a level exceeding 80%, the tendering authority is left with the liberty to take a decision as to whether any Additional Performance Guarantee is to be insisted upon, taking into account the efficiency, reputation, men and machinery engaged, and other positive factors of the respective contractors.
3. If the work has exceeded 30% of the total work, then the tendering authority is directed to secure Additional Performance Guarantee proportionate to the balance work.
4. In all other cases, the contractors/petitioners are directed to furnish an Additional Performance Guarantee to the tendering authority as specified in the tender documents within three weeks from the date of receipt of a copy of this judgment.
5. In cases where a Performance guarantee is furnished by the contractors in spite of its relaxation up to 31.03.2023, the said amounts can be adjusted against the Additional Performance guarantee required in the

circumstances specified above.

6. In cases where 100% bank guarantee is furnished, instead of 50% by way of treasury fixed deposit, the same is permitted to be continued in the facts and circumstances, if the work has exceeded 30% of the total work.
7. If the tenders are invited on the basis of the Percentage Rate Contracts, then the contractors are liable to furnish the Additional Performance Guarantee on the basis of (X-10)% of the estimated PAC.
8. If the tenders are invited on the basis of Items Rates Contract, then the contractors are liable to furnish Additional Performance Guarantee for each item of work on the basis of (X-10)% of the estimated amount for each item of work.
9. I make it clear that the directions are issued as above taking into account the peculiar facts, features and circumstances involved in these cases consequent to the interim orders granted; and it shall not be treated as a precedent, except in regard to the writ petitions pending in the above context."

6. The said directions would strictly apply to the facts and circumstances of these cases with a modified direction that if the tender invited by the Kerala Water

Authority is exceeding Rs. 5 Lakhs, then the contractors shall furnish items rates contract against the items shown in the schedule attached to the notice inviting tender.

7. In that view of the matter, these batch of writ petitions are also disposed of in terms of the common judgment dated 21.03.2023 in W.P.(C.) No. 14051/2022 and other connected cases. However, with a modification that if the tenders are exceeding Rs. 5 Lakhs, the calculation for the aggregate amount of the contract shall be made in accordance with the Government Order dated 04.05.2019 bearing G.O.(P) No. 54/2019/Fin. In all other respects, the directions in the common judgment extracted above would apply. The petitioners as well as the respondents shall comply with the directions as above with the modified direction contained in this batch of writ petitions, as specified above.
