THIS WRIT PETITION (CIVIL) HAVING COME UP FOR ADMISSION ON 14.12.2023, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

## **JUDGMENT**

When this matter was called today, the learned Standing Counsel for the 1st respondent – Kerala State Financial Enterprises (KSFE) submitted that the loan account of the petitioners involved in this case can be settled for a total amount of Rs.20,53,807/-, as on 14.12.2023, along with all applicable charges and interest, provided same is paid by them in not more than 24 equal monthly installments.

2. The learned counsel for the petitioners - Sri.T.K.Ananda Krishnan, accepted the afore suggestion.

Taking note of the afore submissions and in order to obtain a balance between the rival interests of the parties, I allow this writ petition, permitting the petitioners to pay off the aforementioned amount, along with all applicable

charges and interest, in 24 equal monthly installments commencing from 25.01.2024.

Needless to say, if the amounts as afore are paid by the petitioners, the account will stand closed and the KSFE will return to them all security documents as are necessary; but, if on the contrary, any two consecutive instalments are defaulted, the benefit of this judgment will be lost to them and the KSFE will be at full liberty to pursue further action pursuant to Exts.P4 to P5(a), without having to obtain further orders from this Court.

It is also needless to say, therefore, that as long as the amounts as afore are paid, all further action pursuant to Exts.P4 to P5(a) will stand deferred.
