JUDGMENT

The above writ petition (crl.) is filed with following prayers:

- "i) Issue a writ of Mandamus or any other appropriate writ order or direction and direct the 1strespondents to take up Ext.P6 representation preferred by the Petitioner and consider and pass appropriate orders for regularisation of overstay of parole period of the petitioner's husband, Manoj, Convict No. 5503, lodged in Central Prison and Correction Home Thiruvananthapuram, in the light of Ext.P7 Judgment of this Hon'ble Courtas provided under the Kerala Prison and Correctional Services (Management) Rules, 2014, with immediate effect;
- ii) Issue a writ of Mandamus or any other appropriate writ order or direction commanding the 2ndrespondents to grant ordinary leave (ordinary parole) to the petitioner's husbandManoj, Convict No. 5503, lodged in Central Prison and Correction Home Thiruvananthapuram, as provided under the Kerala Prison and Correctional Services (Management) Rules, 2014.
- iii) Issue a writ of Mandamus or any other appropriate writ order or direction and direct the respondents to consider and pass appropriate orders for release of the petitioner's husband, Manoj, Convict No. 5503, lodged in Central

- iv) Declare that the husband of the Petitioner, Manoj, Convict No. 5503, lodged in Central Prison and Correction Home Thiruvananthapuram, is entitled to be considered and released on parole.
- v) to dispense with the translation of the documents produced in the Vernacular Language. vi) Grant such other relief deemed fit to this Hon'ble Court." (sic)
- 2. The petitioner is the wife of Mr.Manoj, Convict No.5503, lodged in Central Prison and Correction Home, Thiruvananthapuram. The husband of the petitioner Mr.Manoj was released on parole from Prison and Correction Netukkaltheri, Open Home. Thiruvananthapuram on 10.02.2023 for fifteen days and he was supposed to return back to prison on 27.02.2023. But he reported back in the prison only on 01.03.2023. Due to the overstay of two days, the further grant of Parole to the husband of the petitioner are suspended by the jail authorities. The petitioner submitted Ext.P6 application for regularization of overstay before the 1st respondent. The same is not considered is the grievance. The petitioner seeks a direction to consider Ext.P6 in the light of Ext.P7 judgment.

- 3. Heard counsel for the petitioner and the public prosecutor.
- 4. After hearing both sides, I think this writ petition can be disposed of directing the 1st respondent to consider Ext.P6 within a time frame.

Therefore, this writ petition (crl.) is disposed of in the following manner:

- 1. The 1st respondent is directed to consider and pass appropriate orders in Ext.P6, as expeditiously as possible, at any rate within one month from the date of receipt of a certified copy of this judgment.
- 2. While deciding the matter, the 1st respondent will also consider the applicability of the dictum laid down in Ext.P7 judgment.
