- 3. 27.09.2024, when this matter came for consideration, this Court passed the following order:

"The memo of charges at page no.21 of memorandum of Contempt Case reads as follows:

"MEMO OF CHARGES AGAINST THE RESPONDENT

That you, Giridhar Aramane, IAS, Defence Secretary, Nerman Bhavan, New Delhi (age and fathers name not known to the petitioner), have failed to comply with the directions of this Hon'ble Court in Annexure-A1 judgement and thereby willfully disobeyed the judgement and thereby interfered with the administration of justice by this Hon'ble Court.
