THIS WRIT PETITION (CIVIL) HAVING COME UP FOR ADMISSION ON 18.12.2018, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

JUDGMENT

Petitioners, owners of extent of 0.2144 an Hectors of dry land located in Sy.No.28/P of Chembukavu Village, Thrissur Taluk, were before this Court by filing W.P.(C) NO. 20807/2018 and secured Ext.P7 judgment dated 25.06.2018, whereby direction was issued to the Sub Collector consider the application submitted by the petitioner seeking permission for utilization of the property for other purposes other than paddy cultivation and agricultural operations. Thereupon application was considered and Ext.P8 order dated 08.10.2018 passed declining permission assigning various reasons. No doubt, Ext.P8 is an appealable order before the Land Revenue Commissioner. I have gone through Ext.P8 order and finds that the findings are rendered by the Statutory Authority on the basis of various factual circumstances which is not expected to be interfered with by this Court at this stage of WP(C).No. 41061 of 2018

the proceedings especially when there is a clear remedy available to the petitioners to prefer an appeal. However, yet another contention put forth by learned counsel for the petitioners is that not only that the permission was declined but also a further direction was issued to the Authorities under the Kerala Conservation of Paddy Land and Wet Land Act, 2008, to make necessary enquiries and identify whether any illegality is committed by the petitioner and take appropriate action.

2. In my considered view being a Head of the Revenue, if anything illegal has come to the notice of the said Authority, the Authority is definitely vested with powers to make any observations and issue direction to any Authorities to take appropriate action if any illegality is committed by a person in order to protect the interest of the Revenue. I do not find anything objectionable to the same and therefore, the writ petition is disposed of leaving open the liberty of the petitioners to approach the Appellate Authority in accordance with

WP(C).No. 41061 of 2018

law. Therefore if the petitioners are making any appeal within three weeks from the date of receipt of a copy of this judgment, it shall be considered by the Appellate Authority treating the same as within the time permitted under law and proceed in accordance with law.

The writ petition is disposed of, accordingly.
