**JUDGMENT**

When this matter was called today, Smt.M.B.Shyni - learned Standing Counsel for the 2<sup>nd</sup> respondent, submitted that, if the petitioner is interested, he can be allowed to pay off the total amount in his loan account, which is a sum of Rs.32,00,070/- as on 09.04.2024, along with all applicable charges and interest, provided she pays the same in not more than 24 equal monthly installments.

Taking note of the afore submissions, I allow this writ petition, permitting the petitioner to pay off the aforementioned amount, along with all applicable charges and interest, in 24 equal monthly installments, commencing
