THIS WRIT PETITION (CIVIL) HAVING COME UP FOR ADMISSION ON
05.04.2024, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

JUDGMENT

The petitioner, who was appointed as UPST in the school managed by the 5th respondent, has approached this Court being aggrieved by the rejection of approval of appointment of the petitioner. The approval was denied on the reason that the appointment of two senior Teachers of the same School was not approved. Exts.P2, P3 and P4 are the orders passed by the various authorities rejecting the approval of appointment of the petitioner. However, later, approval was granted to the seniors of the petitioner and therefore, the embargo in considering the approval of appointment of the petitioner is no longer in existence. In such circumstances the 5th respondent/Manager submitted Ext.P7 revision petition before the 1st respondent which is now pending consideration. The limited prayer sought by the petitioner is for a direction for expeditious disposal of the said revision petition.

After hearing the learned counsel for the petitioner and the learned Government Pleader, this writ petition is disposed of directing the 1st respondent to take up Ext.P7 and pass appropriate
