These writ petitions are filed by the Kerala State Financial Enterprises Ltd. except W. P. (C) No. 21505 of 2024. The common challenge in the writ petitions filed by the KSFE is in regard to the report of the Lok Ayukta. Lok Ayukta passed the impugned report based on the complaints made by the former employees of the KSFE who retired from the service of the KSFE. They approached the Lok Ayukta alleging delay in disbursing gratuity, terminal leave surrender, arrears of Dearness Allowance, etc. The Lok Ayukta found that the delay was on account of maladministration which has caused injustice to the complainants and accordingly ordered payment of dues to such retired employees with six percent interest. According to the KSFE, the delay was occasioned due to an internal audit and on account of the enquiry initiated in this regard and there were no lapses on the part of the KSFE in disbursing the amount. It is submitted now

that the entire benefits have been released except the interest.

2. Writ petitioner in W. P. (C) No. 21505 of 2024 approached this Court as there is a dispute regarding the calculation of his gratuity. It is submitted that the writ petitioner has already approached the Gratuity Controlling Authority for the redressal of his grievances.

3. We have gone through the order passed by the Lok Ayukta. Lok Ayukta had not adverted to individual complaints of each complainant. If there are reasons for the delay in disbursal, that will have to be adjudicated with reference to each individual complaint. In view of the non-inadvertence of the above fact, it is appropriate that those employees approach the competent authority or any other forum available claiming interest. In view of the fact that all other benefits have been released, we set aside the impugned order to the extent of awarding interest and also in regard to finding maladministration without there being an individual enquiry being conducted based on the complaints. We leave open all issues raised in these writ petitions and the complainants are at liberty to claim such benefits, if any, before

the competent authority authorized under law.

With the liberty as above, the impugned report is modified to the above extent. We make it clear that the writ petitioner in W. P. (C) No. 21505 of 2024 is at liberty to agitate his claim for gratuity amount or any other claims before the competent authority.

Accordingly, the writ petitions are disposed of.
