## **ORDER**

Petitioners are the accused in C.C.No. 560 of 2018 on the files of the Judicial First Class Magistrate's Court-IX, Ernakulam. They are facing prosecution for the offences under Sections 353 and 294(b) r/w Section 34 of the Indian Penal Code, 1860.

2. By order dated 27-01-2022, petitioners were granted

permanent exemption from appearance on condition that their counsel shall appear on every posting date representing them and no adjournment shall be sought for on their behalf. However, on 30-04-2024, when the Investigating Officer was scheduled to be examined, the defense counsel was absent, and rejecting the request of the counsel representing the accused, the learned Magistrate cancelled the bail bond and issued a warrant of arrest to the petitioners. The said order is under

challenge in this petition under Section 482 of Cr.P.C.

- 3. I have heard Adv.Saipooja, the learned counsel for the petitioners, as well as Sri.Noushad K.A., the learned Public Prosecutor.
- 4. Petitioners were granted personal exemption on specific conditions. One of the conditions stipulated that the accused shall not seek adjournment and that their counsel shall be present on all posting dates. However, contrary to the said condition, the defense counsel was not present on the date posted for the examination of the Investigating Officer though he was represented by another counsel, and requested for an adjournment.
- 5. Taking into consideration the aforesaid circumstances, I am of the view that the cancellation of the bail bond and the issue of warrant to the petitioners was too harsh a step, as the defense counsel was represented through another counsel. It was not a case where there was no representation at all on behalf of the accused. Taking consideration the into circumstances that the investigating Officer appeared after repeated summons and pursuant to a warrant issued by the court, I am of the view that the impugned order is liable to be interfered with, on terms.

6. Accordingly, Annexure-3 order dated 30-04-2024 cancelling the bail bond of the petitioners and issuing non-bailable warrant is set aside on payment of a cost of Rs.1000/-each to the District Legal Service Authority, Ernakulam. The learned Magistrate shall schedule the case and proceed with the trial on payment of the costs as directed above.
