## **JUDGMENT**

Limited prayer sought by the petitioner is for a direction to the 2<sup>nd</sup> respondent to consider and pass appropriate orders on Ext.P7.

After hearing the learned counsel for the petitioner and the learned standing counsel for the 2<sup>nd</sup> respondent, I am inclined to dispose of this writ petition. Accordingly, it is ordered that the 2<sup>nd</sup> respondent shall take up Ext.P7 representation and a decision thereon shall be taken in accordance with law after hearing the petitioner and the 3<sup>rd</sup> respondent. Decision in this regard shall be taken within a period of one month from the date of receipt of a copy of this judgment.
