JUDGMENT

The petitioner's appointment as LPST in the School managed by the 5th respondent was not approved by the educational authorities on the reason that the petitioner lacks K-TET. Being aggrieved by the same, the petitioner has already submitted Ext.P6 revision petition, which is now pending consideration before the 1st respondent.

2. Limited prayer sought by the petitioner is to direct the 1st respondent to pass orders thereon within a time frame. After hearing the learned counsel for the petitioner and the learned Government Pleader, I am inclined to dispose of this writ petition.

Accordingly, it is ordered that the 1st respondent shall take up Ext.P6 and appropriate orders thereon shall be passed within a period of four months from the date of receipt of a copy of this judgment after hearing the petitioner and the 5th respondent. While taking a decision, the 1st respondent shall taken into account Ext.P7 Government Order as well.
