### JUDGMENT

Petitioner seeks for an expeditious disposal of C.C.No.265/2024 pending on the files of the Judicial First Class Magistrate Court, Ambalappuzha; on the contention that he has been included in the rank list of the Kerala Public Service Commission for the post of Statistics Assistant Grade-II/Statistics Investigator Grade-II and also for the post of Police Constable (Armed Police Battalion).

2. The Supreme Court has time and again observed that the constitutional Courts must in the ordinary course restrain itself from issuing directions for a time bound disposal of cases pending before the trial courts. [Reference to the decision High Court Bar Association, Allahabad v. State of UP & others 2024 INSC 150 is appropriate]. If a direction is issued by this Court, it will be overlooking the priority of other cases. Therefore, the relief sought for is only to be declined.

3. However, if any request for an out of turn priority is sought for

by petitioner, the learned Magistrate will be at liberty to consider the request, notwithstanding the disinclination of this Court to issue any directions in that regard.

With the above observations, this original petition is dismissed.
