ORDER

Petitioners are the defacto complainants in C.C Nos.225/2023, 236/2023 and 200/2023 respectively, on the files of the Judicial First Class Magistrate Court, Chavara, arising out of Crime Nos.99/2023, 100/2023 and 98/2023, registered for the offences punishable under Sections 417 and 420 read with Section 34 of the Indian Penal Code, 1860.

2. The crimes were registered pursuant to separate complaints filed by the defacto complainants alleging that the accused had cheated them by pledging spurious gold ornaments and collecting loan amounts from them. After the investigation commenced on the basis of the three complainants, police seized an amount of Rs.1,82,000/- and produced it in Crime No.98/2023. Subsequently, the three defacto complainants filed separate applications in the above mentioned three cases seeking release of the cash to them. By the impugned orders, the learned Magistrate dismissed all three applications after observing that, though an amount of Rs.1,82,000/- is produced before the court in Crime No.98/2023, no amount has been produced in relation to other two crimes and the investigating officer had not stated the amount in deposit in each crime separately, and hence the court was not able to determine who is better entitled to the possession thereof.

- 3. I have heard Sri. Rajesh R (Ramamoorthy), the learned counsel for the petitioners as well as Smt. Sreeja V. and Sri. Noushad K.A., the learned Public Prosecutors.
- 4. The learned Magistrate had dismissed the application for interim custody filed by the petitioners on the sole ground that the amount seized by the investigating officer has been deposited in one crime and the court was unable to decipher the separate claims. However, all what the court had to do was to have called for a report from the investigating officer to verify the quantum allegedly due to each of the defacto complainants. Having not done so, the impugned orders are liable to be set aside and a reconsideration be directed.
- 5. Accordingly, the impugned orders dated 02.03.2024 in C.M.P No.30/2024 in C.C. No.225/2023, C.M.P No.99/2024 in C.C. No.236/2023, C.M.P No.29/2024 in C.C. No.200/2023, on the files of the Judicial First Class Magistrate Court, Chavara, shall stand set aside. The learned Magistrate shall reconsider the petitions afresh, after calling for a report from the investigating officer. The same shall be done as expeditiously as possible, at any rate, within a period of one month from the date of receipt of the report from the investigating officer.

These Crl.MCs are allowed as above.
