JUDGMENT

The present writ petition has been filed for the following prayers:

- "A. Call for the records relating to Exbt-P1, Exbt-P2 and Exbt-P3 from the respondents.
- B. Quash exhibits P1 and P3 by issuing a Writ of certiorari or any other appropriate writ, order or direction.
- C. To issue a writ of mandamus or any other appropriate writ order or direction directing the respondents to allow the petitioner to pay the outstanding dues in installments and to regularize the loan account, along with regular EMI's.
- D. To grant such other and further reliefs as are just, proper and necessary in the facts and circumstance to the case.
- E. Such other relief's which is deemed to be fit and proper to this Hon'ble Court in the facts and circumstance of the case."
- 2. In compliance of the interim order dated 03.09.2024, the petitioner has remitted an amount of Rs.10 lakhs to the Bank and as of today, the balance overdue amount is Rs.3.5 lakhs.
- 3. The learned counsel for the respondent Bank submits that the petitioner's loan account can be regularised if the petitioner makes the payment of the balance overdue amount



along with regular installments in a few installments, as this Court may fix.

Considering the said stand of the learned counsel for the respondent Bank, the present writ petition is disposed of with following directions:

- 1. The petitioner shall pay the balance overdue amount in three equal monthly installments along with regular installments. The 1st installment is to be paid on or before 15.10.2024 and the remaining two installments to be paid on or before 15th day of each succeeding month.
- 2. After making payment of entire overdue amount along with regular installments, the Bank shall regularise the loan account of the petitioner for making payment of regular installment as per the terms of the loan agreement.
- 3. In case of failure to make payment of 1st installment or any subsequent installments as directed above, the respondent Bank shall be free to proceed with the SARFAESI proceedings against the petitioner to realize its dues, in accordance with law.
