ORDER

Dated this the 16th day of January, 2025

The petitioners are accused Nos.1 to 5 in Crime No.221 of 2021 registered at the Pathanamthitta Police Station for offences punishable under Sections 143,147, 148, 341, 323, 324, and 149 of the Indian Penal Code, now pending as C.C.No.48 of 2021 on the files of the Chief Judicial Magistrate Court, Pathanamthitta.

- 2. The crime was registered on the allegation that, on 10.02.2021 at about 2PM, due to previous enmity, the petitioners, who are SFI activists of Catholicate College, detained the de facto complainant and physically assaulted him, thereby causing injuries.
- 3. Learned Counsel for the petitioners submitted that the dispute, which led to the incident and registration of the crime, is amicably settled and Annexure A3 affidavit has been filed by the 3rd respondent vouching this fact.
- 4. Learned Counsel for the 3rd respondent also submitted that the dispute is settled and his client has no

grievance against the petitioners.

- 5. I heard the learned Public Prosecutor also.
- 6. Having considered the gravity of the offences alleged and having perused the affidavit, the contents of which are vouched to be true and voluntary by the Counsel for the 3rd respondent, I am satisfied that no public interest is involved in this matter and the dispute has been settled amicably. In view of the settlement, there is no possibility of the criminal proceedings ending in conviction. As such, continuance of the proceedings will amount to an abuse of process of court and hence, in view of the legal position set out by the Honourable Supreme Court in **Madan Mohan Abbot v State of Punjab** [(2008) 4 SCC 582] and **Gian Singh v State of Punjab and Another** [(2012) 10 SCC 303], there is no impediment in granting the relief.
- 7. Even though antecedents are reported against the accused, the offences therein being minor and the dispute, in this case, having been settled, the antecedents need not stand in the way of this Court exercising the extraordinary power under Section 528 of BNSS as against accused Nos. 4
