ORDER

After these petitions involving similar facts and common question of law, were heard and reserved and this order was in the process for being dictated, another fresh petition MP. No.6028/2023 came up for hearing in motion on 18.10.2023. Learned counsel for petitioner in MP.

No.6028/2023 submitted that issue involved is the same as that in this bunch of petitions being decided by this common order. Learned counsel for K.V.S., Shri Verma did not dispute aforesaid contention and therefore this common order shall also govern disposal of MP. No.6028/2023 also.

CONTEXT AND CONTENT

2. By three orders dated 12.09.2022, 13.09.2022 and 16.09.2022 the Kendriya Vidyalaya Sangathan (for brevity "K.V.S.") undertook an exercise of rationalization and redistribution with the object to fill up vacancies in those Kendriya Vidyalaya's situated in all over the country where staff incumbency was less than 50%. Large number of Teachers belonging to category of Primary Teacher (P.R.T.), Trained Graduate Teacher (T.G.T.) and Post Graduate Teacher (P.G.T.) situated within territorial jurisdiction of Jabalpur Bench of the Tribunal instituted series of litigation before the Tribunal as well as this Court. After being subjected to four rounds of litigation before the Tribunal and three rounds before this Court, petitioners are before this Court yet again in the fourth round vide this bunch of MPs.

2.1 This Court to avoid prolixity refrains from indulging into factual matrix attending each case and instead intends deciding these matters on the question of law, propriety, equity and relevant subsequent events rather than individual rights and liabilities.

CONTENTIONS

3. Learned counsel for petitioners contend that the exercise of rationalization and redistribution was initiated in view of stalemate arising from interim orders passed by Apex Court in a bunch of petitions pending

in different High Courts and thereafter in the Apex Court where NCTE notification extending priority to B.Ed. qualification for appointment of Teachers over Diploma in Elementary Education, was under challenged. It is urged by learned counsel for petitioners that said controversy stood decided by Apex Court by quashing the notification of NCTE in the case of ***Devesh Sharma vs. Union of India & Others*** reported in **2023 SCC OnLine SC 985**. In view of this changed circumstance, it is urged that entire exercise of rationalization and redistribution needs a fresh look not only about its feasibility but also its viability.

3.1 It is further contended that similarly placed persons, who had approached Principal Bench at New Delhi, Ranch Bench and Jodhpur Bench of the Tribunal were benefited by orders granted by said Benches of allowing said transferred Teachers to apply afresh under the new Transfer Policy of 2023. The petitioners seek similar treatment. More so, it is urged that petitioners ever since the orders of transfer was passed in September, 2022 were protected by judicial interim orders passed either by Tribunal or by this Court till 30.06.2023 (barring a few days in the middle). As such it is submitted that umbrella of protection of interim orders, which was not there for a few days between September, 2022 to 30.06.2023 and thereafter, be ignored in the interest of justice so as to enable petitioners to seek parity with the similarly placed Teachers before Principal Bench at New Delhi, Bench at Ranchi and Bench at Jodhpur.

4. *Per contra*, learned counsel for K.V.S., Shri Verma taking serious objection to the contentions of petitioner objects to the very entertainment of these petitions by emphasizing the extremely limited scope of interference in matters of transfer of service. It is submitted that none of

the grounds on which an order of transfer of service can successfully be assailed (proven malafide, violation of constitutional or statutory provision and breach of service conditions) are made out in these cases. It is also submitted that petitioners are holding the entire education system under K.V.S. to ransom merely to satisfy their personal whims and fancies. As regards parity, it is urged by Shri Verma, learned counsel for K.V.S. that orders of Principal Bench at New Delhi, Ranchi Bench and Jodhpur Bench cannot be made applicable to petitioners since before the said three Benches, Teachers were always protected by interim orders in their favour, which is not the case herein. By referring to order dated 19.06.2023 passed in MP. No.3171/2023, respondents contend that despite direction of this Court, petitioners have not joined at the transferred place thereby demonstrating insubordination.

4.1 It is the submission of learned counsel for K.V.S., Shri Verma that process of fresh induction by direct recruitment as well as promotions has now commenced which may take a few months to conclude.

4.2 Learned counsel for K.V.S. further contends that though a fresh policy of transfer is introduced in 2023, but the petitioners cannot derive any benefit from the same since cause of action of petitioners is of September, 2022.

FINDINGS

5. After hearing learned counsel for rival parties at length, this Court finds that instant case is essentially of rationalization and redistribution but not of mere transfer. The K.V.S. was compelled to initiate the process of this exercise in view of non holding of fresh recruitments in different

categories of post of Teachers which in turn was *inter alia* due to stalemate created by pendency of litigations before various High Courts assailing the notification of NCTE, which culminated into judgment by Apex Court in **Devesh Sharma** (supra). The decision by Apex Court in **Devesh Sharma** (supra) was rendered on 11.08.2023 whereafter K.V.S. has commenced the process of recruitment by direct appointment/promotion in different cadres of Teachers in K.V.S.

6. It is palpable from the record that except for a few days between September, 2022 to 30.06.2023 and thereafter the petitioners did not enjoy the protection of interim orders from any judicial forum. Thus, what is clear is that from September, 2022 to 30.06.2023 for a period of 9-10 months petitioners were protected by interim orders passed either by Tribunal or by this Court. Pertinently, these petitions were filed in the first week of September 2022 meaning thereby that petitioners are without any protection of interim orders by this Court for only two months, which ought not to be treated to their disadvantage especially when similarly placed Teachers had been benefited by other Benches of Tribunal (Principal Bench at New Delhi, Ranchi Bench and Jodhpur Bench). As such denying benefit of parity to petitioners would not only be harsh but also discriminatory. Thus, this Court deems it appropriate to extend the benefit of orders passed by Principal Bench at New Delhi, Ranchi Bench and Jodhpur Bench to petitioners therein.

7. Coming to other ground raised by K.V.S. of limited scope of interference in transfer matters, this Court at the cost of reiteration emphasizes that instant case is not of transfer but predominantly of rationalization and redistribution and therefore judicial scrutiny of the

same cannot deal with the magnifying glass prescribed for looking at transfer matters simplicitor. Thus, scope of interference in such matters of rationalization and redistribution is wider as compared to matters purely of transfer of service.

8. Another aspect which deserves consideration is that no one has joined at the place of transfer of petitioners and therefore fresh exercise of recruitment by way of direct appointment/promotion which is underway can very well be expedited and taken to its logical end. This will not only fill up large number of vacancies in those K.V.S., which have more than 50% staff efficiency but as a necessary consequence would eliminate, to a large extent, the need to transfer petitioners.

8.1 However, aforesaid observation of this Court does not curtail the right of the employer to post any Teacher liable to be transferred at any place but since we are essentially dealing the process of rationalization and redistribution, this Court deems it appropriate to cause indulgence.

9. Great emphasis has been laid by learned counsel for K.V.S. on the order passed by this Court on 19.06.2023 in MP. No.3171/2023 whereby the Coordinate Bench of this Court had fixed a timeline for deciding representations of the Teachers of K.V.S. and thereafter directed that in case of rejection of representations Teachers ought to join at the transferred place in public interest.

9.1 True it is that aforesaid order was passed but at the relevant point of time three Benches of the Tribunal (Principal Bench at New Delhi, Ranchi Bench and Jodhpur Bench) had not passed orders as aforesaid in case of similarly placed Teachers of K.V.S. and therefore this Court is compelled

to take a view, which though ostensibly appears to be at variance to aforesaid order passed on 19.06.2023 in MP. No.3171/2023 but is justified in the changed facts and circumstances as aforesaid.

10. It may not be out of place to mention here that academic session of 2023-24 is past its mid point and the post from which petitioners had been transferred and relieved continue to lie vacant. As such in the interest of right of education of students, it would be appropriate to allow petitioners to join back on the post from which they had been transferred situated in different K.V.Ss. in the State of M.P. and await outcome of exercise of fresh recruitment by direct appointment/promotion.

11. Consequent upon aforesaid these petitions including MP. No.6028/2023 are allowed to the following extent:-

(i) Impugned orders of transfer of petitioners passed on 12.09.2022, 13.09.2022 and 16.09.2022 so far as they pertain to petitioners before this Court are set aside.

(ii) The K.V.S. is directed to allow petitioners before this Court to join back at the place from which they were transferred and to continue them awaiting outcome of exercise of fresh recruitment (direct appointment/promotion).

(iii) The K.V.S. is further directed to ensure completion of exercise of fresh recruitment of Teachers of different categories by direct appointment/promotion as expeditiously as possible preferably well before the end of academic session of 2023-24.

(iv) After completion of process of fresh recruitment in the cadre of Teachers (direct appointment/promotion), K.V.S. is

directed to undertake exercise of rationalization and redistribution on those posts which continued to remain vacant after adjustment of all the fresh recruits appointed/promoted pursuant to aforesaid exercise of fresh recruitment.

(v) Petitioners be also permitted to apply under new transfer policy of 2023 to maintain parity with those Teachers before Principal Bench at New Delhi, Ranchi Bench and Jodhpur Bench of the Tribunal.

(vi) It is made clear that in case any of the petitioners is found liable to be transferred during the process of fresh exercise of rationalization and redistribution after conducting fresh recruitment by direct appointment/promotion, petitioners shall be liable to be transferred as per prevailing transfer policy of 2023.

10. With the aforesaid directions, these petitions stand allowed to the aforesaid extent sans cost.
