This application coming on for motion this day, the court passed the following:

#### **ORDER**

This **first** application under Section 439 of the Code of Criminal Procedure, 1973 has been filed for grant of bail by the applicant in connection with Crime No.137/2022, for the offences punishable under Section 376 of the IPC and Section 3/4 of the POCSO Act.

The applicant is in judicial custody since 10.06.2022 in the aforesaid case. The allegation against him is of having raped the prosecutrix who is a minor aged 15 years. The applicant himself is 22 years of age. The statement

under Section 164 of the Cr.P.C. of the prosecutrix reveals that she has gone to several places alongwith the present applicant.

Learned counsel for the applicant has submitted that the case is one of consent and that the charge of rape is one under statutory rape on account of the minority of the prosecutrix, and not a case of forcible rape.

Learned counsel for the State has opposed the application for grant of bail on account of the minority of the prosecutrix.

Be that as it may, looking at the facts and circumstances of the case especially statement under Section 164 of the prosecutrix and the period of incarceration already undergone by the applicant herein, the application is allowed. It is directed that the applicant herein shall be enlarged on bail upon his furnishing a personal bond in the sum of Rs.50,000/- (Rupees Fifty Thousand Only) with one solvent surety in the like amount to the satisfaction of the learned trial court.
