As per report of Registry, appellant No.1 has since expired.  
Appellant No.2 has been duly served. Notice issued to appellant No.3 has  
been received back with the report that he is residing in Canada.

The matter has been discussed. As agreed, as per statements of  
appellant No.2, learned counsel for the appellants and learned counsel for  
the Insurance Company (separately recorded), a sum of ₹8,25,000/- (₹ Eight  
Lakh Twenty Five Thousand Only) over and above the amount awarded by  
the Tribunal is allowed to the appellants in full and final settlement of the  
claim in this appeal. As per the statement of learned counsel for the  
appellants, the enhanced amount be paid to appellant Nos.2 and 3 in equal  
shares.

It has been stated by learned counsel for the appellants that as  
per Aadhar Card of appellant No.2, his name is Kirpal Singh Bath whereas  
in the Memo of Parties, his name is Kirpal Singh and that appellant No.2 has  
mentioned his surname as well along with his name and that his bank

account is also in this name and hence, cheque be issued in the name of Kirpal Singh Bath. He has placed on record copy of Aadhar Card of appellant No.2.

It has been further stated by learned counsel for the appellants that in the Bank Account of appellant No.3, the spelling of his name is Jasvir Singh whereas in the Memo of Parties, the spelling of his name is mentioned as Jasbir Singh and that hence, cheque be issued in the name of Jasvir Singh. He has also placed on record copy of Bank account of appellant No.3.

Accordingly, we dispose of this case with a direction to the Insurance Company to deposit crossed-cheques in the sum of ₹8,25,000/- in the respective names of appellant Nos.2 and 3 in equal shares with the office of the Lok Adalat of the High Court on or before 02.07.2025, in compliance of this order, failing which, interest @ 9% per annum shall follow on this amount from the date of this order till payment. The concerned Officer of the Lok Adalat Branch/Office shall issue proper receipt after receiving the cheques to learned counsel/representative of the respondent-Insurance Company. The appellant(s)' counsel/appellant(s) may collect the cheques from the office of the Lok Adalat.

Copy of the order be supplied/sent to the counsel/parties and file be returned to the Hon'ble High Court.
