Today, Power of Attorney on behalf of appellant Nos.2, 3 and 6 has been filed by Mr.Ram Lal Yadav, Advocate, which is taken on the record. He has stated that appellant No.5 has since expired and his L.Rs are already on the record. There is no other L.R of appellant No.5.

As agreed, as per statements of appellant Nos.1, 3 and 4, learned counsel for the appellants and learned counsel for the Insurance Company (separately recorded), a sum of ₹11,10,000/- (₹ Eleven Lakh Ten Thousand Only) over and above the amount awarded by the Tribunal is allowed to the appellants in full and final settlement of the claim in this appeal. As per the statement of learned counsel for the appellants, out of the enhanced amount of ₹11,10,000/-, ₹2,00,000/- be paid to appellant No.6 i.e. mother of the deceased and remaining amount be paid to appellant No.1 i.e. widow of the deceased.

It has been stated by learned counsel for the appellants that though in the claim petition, name of appellant No.1 has been mentioned as Smt. Sukhwanti, however, as per her Aadhar Card, her name is Smt.Sukhbanti and that her account number is also in this name only.

Photocopy of her Aadhar Card is also placed on the record. Hence, he requests that Insurance Company be directed to issue cheque in the name of Smt. Sukhbanti.

Accordingly, we dispose of this case with a direction to the Insurance Company to deposit two crossed-cheques i.e. one for ₹2,00,000/- in the name of appellant No.6 i.e. mother of the deceased and another for ₹9,10,000/- in the name of appellant No.1 - Smt.Sukhbanti wife of late Shri Shiv Ram Chaudhary (in total ₹11,10,000/-) with the office of the Lok Adalat of the High Court on or before 15.10.2024, in compliance of this order, failing which, interest @ 9% per annum shall follow on this amount from the date of this order till payment. The concerned Officer of the Lok Adalat Branch/Office shall issue proper receipt after receiving the cheques to learned counsel/representative of the respondent-Insurance Company. The appellant(s)' counsel/appellant(s) may collect the cheques from the office of the Lok Adalat.

Copy of the order be supplied/sent to the counsel/parties and file be returned to the Hon'ble High Court.
