seeking directions to the respondents to release funds for undertaking construction of railway underbridge (hereinafter referred as 'RUB') and Railway Authorities may be directed to accept the construction of RUB in site in question.

It is submitted by the learned counsel for the respondent-Railways that after receiving the proposal the sanction has already been granted for the purpose of construction of RUB and learned Additional Advocate General submits that fund has already been sanctioned and process for finalisation of tender has been going on and therefore nothing survives in this petition.

After considering the submissions made by the learned counsel for the parties we are of the opinion that final sanction has already been granted by the State Government and Railway Authorities have approved the technical plan, therefore, now it is the duty of the respondents to finalise the tender process and commence the construction work.

Consequently, this Public Interest Litigation is disposed of with direction to the State Government to complete the process of tender within a period of three months from today and thereafter proceed with final construction of the RUB in question.
