These bail applications have been filed by petitioners under Section 439 Cr.P.C. seeking regular bail in FIR No.281/2023 registered at Police Station Mandawar (Dausa), District Dausa for the offence(s) under Section(s) 419, 420, 467, 468, 471, 120-B & 379 IPC.
