Order

1. Apprehending his arrest in connection with FIR No.273/2021 registered at Police Station Chabra, District Baran for the offence(s) under Sections 147, 148, 149, 341, 323, 332, 333, 353, 307, 395, 436, 427, 153A, 186, 188, 268, 269 of IPC and Sections 4, 5, 6 of Rajasthan Epidemic Act and Section 51 of Disaster Management Act, the petitioners have preferred these anticipatory bail applications under Section 438 of Cr.P.C.
2. Learned counsel for the accused-petitioners submits that the accused-petitioners have been falsely implicated in this cases. The similarly situated co-accused has already been granted bail. The case of the present petitioners are not distinguishable than that of other co-accused.
3. Learned Public Prosecutor has vehemently opposed the bail applications.

4. Having considered the overall allegations leveled in the FIR and contentions made by the counsel for the accused-petitioners.

5. Taking into account the totality of facts and circumstances of the cases and without expressing any opinion on the merits of the cases, this court deems it just and proper to allow the anticipatory bail applications.

6.. Accordingly, the anticipatory bail applications are allowed. The S.H.O/I.O/Arresting Officer, Police Station Chabra, District Baran in F.I.R. No. 273/2021 is directed that in the event of arrest of the petitioners namely **1. Shyojiram S/o Shri Ghasilal** **2. Bhuralal S/o Radhakishan** **3. Ranveer S/o Shri Prithviraj** **4. Komal @ Kamal S/o Newaji** **5.Cheetarlal S/o Mansingh** **6. Meghraj S/o Cheetarlal** **7. Himmat Singh S/o Shri Babulal** **8.Rajendra S/o Shri Laddulal** they shall be released on bail, provided each of them furnishes a personal bond in the sum of Rs.50,000/- with two sureties in the sum of Rs.25,000/- each to the satisfaction of the S.H.O/I.O/Arresting Officer of the concerned Police Station on the following conditions:-

- (i) that the petitioners shall make themselves available for interrogation

by a police officer as and when required;

(ii) that the petitioners shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the court or any police officer, and

(iii) that the petitioners shall not leave India without previous permission of the court.
