UPON hearing the counsel the Court made the following O R D E R

- There is an inordinate delay of 2683 days in filing of the present Special Leave Petitions and that too after the dismissal of a batch of earlier matters.
- 2. It may be noted that earlier the petitioner UOI had filed only one appeal being C.A. No. 23521/2017 (UOI vs. Major Pritam Singh) against the impugned common order dated 17.02.2016 passed by the High Court disposing of 347 appeals before it. This Court vide the order dated 23.02.2023 dismissed the said appeal only on the ground that when the judgment of High Court qua large number of claimants had attained finality, there was

no justification to consider the question raised at the instance of UOI and that no two different standards could be adopted by UOI in reference to the claimants who are covered under the self-same land acquisition proceedings. Thereafter the Review Petition filed in the said C.A. was also dismissed on 02.08.2023. Again, this Court dismissed a batch of 271 SLPs filed by the UOI challenging the said self-same judgment vide the order dated 03.01.2024. Now, this batch of SLPs have been filed challenging the same judgment dated 17.02.2016 by the UOI with the delay of 2683 days without any justification whatsoever particularly for the period from February, 2017 to February, 2023 (about six years).

- learned Banerjee, 3. The A.S.G., Mr. seeks time to take instructions, as to what action shall be taken by the department for fixing the accountability of the officers, for not filing the Special Leave Petitions for such a long time, and to avoid such delay in future.
