### **SLP NO. 1838/2015**

It is submitted that counsel for petitioner has filed applications for directions, permission to file additional documents and official Translation but the application for O.T is still defective for the reasons that :

1. Copy of application for direction not served to other side Advocate.
2. Page no. 32 is missing and some blank spaces in application for additional document & Advocate has not cured the defects.

It is further submitted that counsel has cured the defect in application for direction is registered as IA No. 3. As the matter is on board, both applications are being circulated with this office report.
