O R D E R

I.A. Nos. 3 of 2013 for filing additional documents and for permission to amend Writ Petition:

Registry has committed an error as two I.As. have been numbered as I.A. No. 3 of 2013. For the sake of convenience, the application seeking permission for filing additional documents is treated as I.A. No. 3 of 2013 and the application seeking amendment in the Writ Petition is treated as I.A. No. 3A of 2013.

I.A. No. 3 of 2013 for permission to file additional documents is granted.

As regards amendment in the Writ Petition, as set-out in paragraph 4 of I.A. No. 3A of 2013, we are satisfied that leave may be granted to the petitioners to make such amendments. I.A.
