O R D E R

- 1 This transfer petition has been filed by the petitioner-wife for transfer of HMA Petition No 262 of 2021 titled “Deepak Kumar vs Sonam” from the Court of the Family Judge, District and Sessions Court, Bareilly, Uttar Pradesh to the Court of the Principal Judge, Family Court, Shahdara District, Karkardooma Courts, Delhi.
- 2 We have heard counsel appearing on behalf of the petitioner.
- 3 The office report indicates that service is complete, but none has entered appearance on behalf of the sole respondent.
- 4 Having regard to the interests of justice, we are of the view that an order for the transfer of the proceedings is warranted. We accordingly allow the transfer petition and direct that HMA Petition No 262 of 2021 titled “Deepak Kumar vs Sonam” be transferred from the Court of the Family Judge, District and Sessions Court, Bareilly, Uttar Pradesh to the Court of the Principal Judge, Family Court, Shahdara District, Karkardooma Courts, Delhi.

- 5 The transferor court shall forthwith transmit the record of the aforesaid case to the transferee court.
- 6 After transfer of the petition, the transferee Court is directed to make all endeavour either for amicable settlement or for early decision in the matter without unnecessary adjournments.
- 7 Pending application(s), if any, stands disposed of.
