depositing the entire compensation amount with  
statutory benefits as awarded by the Reference  
Court within a period of six weeks from today.

aforesaid order, the interim order of stay shall  
stand vacated automatically.

losers to make their necessary applications and  
seek withdrawal of the said amount.

shall be considered and disposed of expeditiously."
