**OFFICE REPORT**

The SLP(C) 6250/2015 alongwith connected matters were listed before the Hon'ble Court on 29.03.2016, when the Court was pleased to pass the following Order:-

**"The learned counsel for the petitioner seeks  
two more weeks'time to file a chart as directed by  
this Court on 14.10.2015.**

**The time, as prayed for, is granted.**

The chart shall clearly indicate as to the date of taking possession and the mode of taking possession of each item of the property, if at all they have taken possession.

It shall also be indicated in the chart the mode of payment or deposit of compensation of each item.

A copy of the chart shall be furnished to the respondent on or before 10.04.2016.

In case the chart is not filed on or before 10.04.2016, it shall be presumed that they have not taken physical possession of the property and the officers responsible for not filing the chart shall be personally made liable for the consequences.

Post on 12.04.2016 on top of the list.

In the batch, the cases shall be serially numbered while listing.

Delay condoned and issue notice in all the fresh matters returnable on 12.04.2016.

List all the matters on 12.04.2016."

It is submitted that in pursuance of above order, M/s Saharya & co. Advocates appearing for DDA has on 21.04.2016 filed affidavit with annexures as Chart indicating categories with the leave of Hon'ble Court but the annexures to the above affidavit are typed in small font size. Despite this Registry's letter dated 22.04.2016, he has not filed legible copies of the annexures so far. However the said affidavit is being circulated herewith.

It is further submitted that in SLP Nos. 22122/2015 and 30729/2015 M/s B.K. Prasad & Kamendra Mishra Advocates have on 23.04.2016 filed applications for impleadment /intervention alongwith Vakalatnama/Appearance on behalf of the applicants but its copies have not been served on the other side. However, the unregistered applications have been placed with respective SLP Paper books.

It is further submitted that in SLP(C) No. 30734/2015, 19204/2015, 7749/2016 and 17006/2015 M/s Aruputham Aruna & Co.
