O R D E R

The mediation report of the settlement has been received from the Tamil Nadu Mediation and Conciliation Centre, High Court, Madras.

In terms of the settlement dated 31.10.2022 it has been agreed that the respondent husband would pay a sum of Rs.10 lakhs and return one gold chain and two *lehengas* and one gown to the petitioner-wife at the time of passing of the dissolution of marriage decree. The petitioner wife would return the *Mangal sutra* to the husband. The parties have stated that no other disputes survive *inter se* the parties.

In view of the aforesaid, the parties may seek divorce by mutual consent by moving the Courts in Madras when exchange of goods can also take place. The proceedings in Patna filed by the husband are also for divorce and thus, that proceedings would stand disposed of.

The settlement agreement is taken on record and parties will remain bound by the same.

We appreciate the stand taken by the parties and role played by the learned Mediator and learned counsels for parties.

The Transfer Petition stands disposed of.
