UPON hearing the counsel the Court made the following
 O R D E R

In keeping with the directions issued by this Court in its Order dated 12.09.2022, these matters are listed today.

Right at the outset, Mr. Tushar Mehta, learned Solicitor General, has submitted that the responses on behalf of the States of Assam and Tripura have not yet been filed and that he may be given some additional time to comply with the directions issued by this Court.

Having noted that there are number of matters projecting multiple issues, in our view,

the resolution to the instant controversy can be effectively and easily achieved if two or three matters are taken to be the lead matters and convenience compilations, including written submissions of all the learned counsel, are prepared well in advance. Such process will make the conduct of the proceedings convenient and easy.

We have been apprised that Writ Petition (C) No.1470 of 2019 filed by *Indian Union of Muslim League & Others* is complete in every respect and that, the pleadings in said case matter have been filed. Said petition has been filed by Ms. Pallavi Pratap, learned Advocate-on-Record of this Court.

We, therefore, appoint Ms. Pallavi Pratap, learned Advocate on behalf of the petitioners and Mr. Kanu Agrawal on behalf of the respondents, as nodal counsel. Both the learned counsel are requested to have common compilations of all the relevant documents.

After the exercise of compiling documents is done, the learned counsel may share the volumes of compilations with every learned counsel, who has entered appearance in the matters. Let the copies be shared in digital version.

We also request all the learned counsel to file their written submissions, not exceeding three pages, and to indicate the time required for them to project their submissions.

After all the exercise is done in the lead matter, the nodal counsel may also consider designating one or two other matters as lead matters in other categories keeping in view the challenges raised on grounds of geographical classification, regional classification and such other issues.

The learned counsel for the States of Assam and Tripura shall file their counter affidavits within two weeks and the nodal counsel shall then compile everything within three weeks thereafter.

List these matters before the appropriate Court on 6th December, 2022.
