The Transfer Petitions above mentioned were listed before the Hon'ble Court on 13<sup>th</sup> March, 2015 when the Court was pleased to pass the following Order:-

"Issue notice to the Union of India, returnable next week.

Liberty to serve the Union of India through its Standing Counsel in this Court.

List again next week."

Accordingly, notice was issued to the Union of India in both matters through concerned High Courts on 17-03-2015 as well as Dasti through standing counsel.

Thereafter the matter were again Listed on 20-03-2015 when Court was pleased to pass the following Order:-

"Learned counsel for the petitioners is granted two weeks' time, so as to enable him to file proof of service on the respondents. List thereafter."
