3. Our attention is drawn to the Order dated 15.04.2024 passed by this Court in Civil Appeal No.4958 of 2024 arising out of SLP(C) No. 9957 of 2023. This Court, in the said order, took note of an earlier order passed in Civil Appeal Nos. 9425-9475 of 2018, titled "*VISHVANATH S/O NARAYAN LATE ETC. V. THE STATE OF MAHARASHTRA AND ORS. ETC.*", and remanded the matter for reconsideration to the High Court. Further, in the said order, it was clarified that the appellant would not be entitled to interest as well as other statutory benefits for the period of default/delay in filing the present appeal or in the past as well.

are remanded to the High Court for consideration, on similar terms as had been directed in Civil Appeal No.4958 of 2024.
