3. The present petition has been filed by the petitioner-wife seeking transfer of a petition being FC OP No. 632 of 2023 titled as "*Panthagani Arun Pratap Singh vs. Palle @ Panthagani Gowthami Chandra*" pending before the Court of the learned Principal Family Judge, Vijayawada, Andhra Pradesh to the Family Court, Medchal-Malkajgiri District, Telangana.
