**O R D E R**

**SLP (C) No. 367/2019**

Four weeks time, as last chance is granted to respondent Nos. 1 and 3, to file counter affidavit.

Two weeks time, as last chance is granted to the petitioner, for furnishing fresh particulars and to take fresh steps in respect of respondent No.2 or to file dasti proof in respect of said respondent, who is unserved.

List again on 3.8.2023.

**SLP (C) No.11300/2019**

Despite service of notice on respondent Nos. 1 to 11, 13 to 22, there is no appearance on their behalf.

Respondent No.23 has already filed the counter affidavit.

Four weeks time, as last chance is granted to respondent Nos. 24 to 26, to file counter affidavit.
