C.A. No. 9023 of 2011

Await certificate of service of respondents from the High  
Court and reminder be issued to this effect.

Fresh alternative arrangement notice be issued to the appellant.

C.A. No. 9024 of 2011

Await certificate of service of respondent Nos. 1 to 40, 42 to 53 from the High Court and reminder be issued to this effect.

Opportunity to respondent No. 41 to file counter affidavit has already been declined.

C.A. No. 9026 of 2011
