OFFICE REPORT

It is submitted that the above mentioned Special Leave Petition is filed by Mr. Subhash Bhowmick, Advocate on 27.01.2016 against the Judgment and Order dated 05.08.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA No.2988, 5303 of 2010 and 2809 of 2013 along with applications for Application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for **substitution** of deceased sole petitioner namely Baljeet in RFA No. 2988 of 2010 which is barred by time by 1525 days and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that Special Leave Petition

filed against the Judgment and Order dated 05.08.2015 in RFA No. in RFA No.2988, 5303 of 2010 and 2809 of 2013 is barred by time by 83 days and Counsel for the petitioner has filed an application for condonation of delay in filing the Special Leave Petition

It is further submitted that notice in SLP (C) No.4200 of 2016 @ CC no. 368 of 2016 entitled Angoori Devi and Ors. Versus State of Haryana and Ors. Arising out of common order was directed by the Hon'ble Court on 05.02.2016. SLPs is pending. (Copy of order dated 05.02.2016 is enclosed herewith).

It is further submitted that CC No. 2093 of 2016 entitled Ram Sarup Versus State of Haryana and Anr. arising out of common order is a 1N matter.

It is further submitted that Counsel has not furnished copies of the notification dated 6.7.2000, 7.7.2000 and Award dated 9.01.2002 mentioned in the impugned order. In this regard, **counsel has given a letter** 12.02.2016 stating therein that the same are not necessary for the adjudication of the matter. Counsel has requested to ignore the said defects and register the matter at his own risk.

The matter above mentioned is listed before the Hon'ble Court with this office report.
