**UPON hearing the counsel the Court made the following  
 O R D E R**

In pursuance of the directions issued by this Court in its judgement dated 13.05.2016 in Uddar Gagan Properties Ltd. vs. *Sant Singh & Ors.* [(2016) 11 SCC 378], a committee under the Chairmanship of Hon'ble Mr. Justice (Retd.) R.S. Madan was constituted which in turn has made certain recommendations.

Learned counsel for the State submits that in keeping with these recommendations, the role of certain officials has to be gone into and an inquiry in that behalf is presently being conducted by the Principal Secretary, Department of Irrigation. In his submission, the inquiry will complete within six weeks and the report shall thereafter be placed on record before this Court. The statement is recorded.

Mr. Shyam Divan, learned senior advocate moved IA No.102644/2019 seeking certain reliefs.

Issue notice on IA No.102644/2019. Liberty is granted to the State to file response within three weeks. Rejoinder, if any, be filed within a week thereafter.

Learned Amicus Curiae has also filed his submissions in the form of a Note, which is taken on record.

Response, if any, as regards said Note shall be filed within three weeks from today.
